**A RESOLUTION APPROVING THE PURCHASE UNDER FLORIDA SHERIFF'S ASSOCIATION CONTRACT NO. FSA25-VEL33.0 OF TWO (2) FORD POLICE RESPONDERS MARKED TRAFFIC AND TWO (2) FORD POLICE RESPONDERS MARKED DUI FROM DUVAL FORD, LLC IN THE TOTAL AMOUNT OF \$211,732 FOR USE BY THE TAMPA POLICE DEPARTMENT; AUTHORIZING THE DIRECTOR OF PURCHASING TO PURCHASE SAID PROPERTY, SUPPLIES, MATERIALS OR SERVICES; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS,** Chapter 2004-466, Laws of Florida, as amended by Chapter 2012-239, Laws of Florida, is legislation pertaining to cooperative procurements in Hillsborough County. The law authorizes public bodies operating in Hillsborough County to purchase goods and services from contracts entered into by other federal, state, local governmental entities and certain tax-exempt organizations under the same terms of the Bid/RFP submitted to said entity or organization, providing that the contract was procured in compliance with the procuring entity's or organization's laws, rules, regulations or ordinances and was issued using full and open competition; and

**WHEREAS,** the City of Tampa ("City") has a need for two (2) Ford Police Responders marked Traffic and two (2) Ford Police Responders marked DUI for use by the Tampa Police Department; and

**WHEREAS,** the Florida Sheriff's Association, a not-for-profit 501(c)3 corporation, registered in the State of Florida offers a statewide purchasing contract for local and county governments, county sheriff's, and other public agencies, issued an Invitation to Bid for the purchase of Pursuit, Administrative, and Other Vehicles, and awarded Contract No. FSA25-VEL33.0 to Duval Ford, LLC for sales in Florida; and

**WHEREAS,** the City of Tampa desires to take advantage of Contract No. FSA25-VEL33.0 with Duval Ford, LLC for the purchase of two (2) Ford Police Responders marked Traffic and two (2) Ford Police Responders marked DUI for use by the Tampa Police Department; and

**WHEREAS,** it is in the best interest of the City to approve such purchase from Duval Ford, LLC.

**NOW, THEREFORE,****BE IT RESOLVED BY THE CITY COUNCIL  
OF THE CITY OF TAMPA, FLORIDA:**

**Section 1.** That the purchase by the City of Tampa of two (2) Ford Police Responders marked Traffic and two (2) Ford Police Responders marked DUI for use by the Tampa Police Department from Duval Ford, LLC is hereby approved; and the Director of Purchasing is hereby authorized to purchase same.

**Section 2.** This Resolution approves the purchase of two (2) Ford Police Responders marked Traffic and two (2) Ford Police Responders marked DUI from Duval Ford, LLC under Florida Sheriff's Association Contract No. FSA25-VEL33.0 and provides \$211,732 for use by the Tampa Police Department within the Fleet CIT Program #6 Fund.

**Section 3.** That the other proper officers of the City of Tampa are hereby authorized to do all things necessary and proper in order to carry out the terms and conditions of this Resolution which shall take effect immediately upon its adoption.
