

RESOLUTION NO. 2026-___

A RESOLUTION OF THE CITY OF TAMPA, FLORIDA ACCEPTING A MONETARY DONATION FROM THE FRANK MANGANO FOUNDATION IN THE AMOUNT OF FIVE THOUSAND DOLLARS (\$5,000) FOR UNRESTRICTED USE BY TAMPA FIRE & RESCUE; AUTHORIZING THE MAYOR OF THE CITY OF TAMPA TO EXECUTE THE ACCEPTANCE OF SAID DONATION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Tampa (“City”) on behalf of Tampa Fire & Rescue (“TFR”) desires to accept a monetary donation from The Frank Mangano Foundation (“Donor”) in the amount of Five Thousand Dollars (\$5,000) for unrestricted use by TFR; and

WHEREAS, acceptance of the donation is being undertaken in a manner consistent with the City Acceptance of Gifts & Donation Policy; and

WHEREAS, this Resolution accepts a monetary donation from Donor in the amount of Five Thousand Dollars (\$5,000) for unrestricted use by TFR; and

WHEREAS, Donor has provided an unsolicited check in the amount of Five Thousand Dollars (\$5,000) for unrestricted use by TFR, (a copy of which is attached hereto as composite Exhibit A); and

WHEREAS, City Council does hereby affirm that it would be beneficial to the residents of the City to approve acceptance of the donation.

NOW, THEREFORE,

**BE IT RESOLVED BY THE CITY
COUNCIL OF THE CITY OF TAMPA,
FLORIDA:**

Section 1. This Resolution accepting a monetary donation from The Frank Mangano Foundation (“Donor”) in the amount of Five Thousand Dollars (\$5,000) for unrestricted use by Tampa Fire & Rescue, is approved in its entirety or in a form substantially similar thereto.

Section 2. That the Mayor is authorized to execute, and the City Clerk to attest, the Instrument of Donation for the purpose of accepting the monetary donation, attached hereto.

Section 3. That the proper officers of the City are hereby authorized to do all things

necessary and proper to carry out and make effective the provisions of this Resolution.

Section 4. That this Resolution shall take effect immediately upon its adoption.

Section 5. That the City Clerk shall file a fully executed copy of the Instrument of Donation in the official records of the City of Tampa as maintained by the Office of the City Clerk.


