### **Statement of Basis for Petition for Review**

Pursuant to City of Tampa Code Section 27-61, we hereby petition for review of the formal decision issued September 12, 2025 (FDN-25-156), concerning the property located at 4312 West Laurel Street, Tampa, FL 33607.

The Zoning Administrator determined that the existing duplex use of the property was not legally established in January 1956 and therefore is not eligible for recognition as a nonconforming use. Respectfully, this determination did not correctly apply the governing provisions of the City of Tampa Code.

**1. Standard for Establishing Nonconformities (Sections 27-43 and 27-291).**

Under Section 27-43, a nonconformity exists where a use or structure was legal at the time established and later rendered nonconforming by subsequent zoning amendments. Section 27-291 requires that the applicant demonstrate that the nonconformity was once conforming and became nonconforming due to a later code change. The decision presumes that the duplex must be proven to have existed prior to the 1956 adoption of the R-1 district. However, the record includes multiple forms of acceptable evidence (Polk Directories from the 1960's onward, 1962 property card, Situs records, and survey) showing longstanding duplex use, which should have been weighed under Sections 27-291 and 27-297(3).

**2. Interpretation of the 1956 Zoning Transition.**

The conclusion that the duplex must have existed prior to 1956 effectively eliminates the possibility of nonconforming recognition for structures built after that date but before the RS-50 rezoning in 1987. This interpretation is inconsistent with the Code's plain language, which requires only that the use was legal when established — not that it predated the 1956 zoning ordinance. If the duplex was constructed in the early 1960's and recorded as a duplex in City and County records, this raises a substantial question as to whether it was lawfully permitted at that time under the regulations then in force.

**3. Evaluation of Evidence Under Section 27-297(3).**

Section 27-297(3) lists acceptable evidence to establish the continuation of a nonconforming use, including public records, utility records, property records, surveys, and Polk Directory listings. The applicant submitted this type of evidence. However, the decisions dismissed the documentation as "insufficient," without explaining why these materials that are recognized by the Code were not credited. In addition, one of the documents provided to the City was a "Situs" document showing that the structure was lawfully permitted as a duplex. Situs only reflects structures that received permits from the City.

Accordingly, the denial of nonconforming status conflicts with Sections 27-43, 27-291, and 27-297 of the City of Tampa Code.

The property generally located at 4312 West Laurel Street is zoned Single-Family Residential (RS-50). The property may be developed according to the regulations as stated in Chapter 27 of the City of Tampa Code, specifically [Section 27-156](#), [Table 4-1](#) & [Table 4-2](#).

Per 27-291, to establish a nonconformity, the applicant must demonstrate that the nonconformity must have been deemed conforming under the former zoning code and made nonconforming and continue to be designated nonconforming by the provisions of this chapter or subsequent amendments hereto.

The submitted application is asking for a determination of the nonconforming status of a duplex dwelling unit located on the property. I have reviewed the information submitted, the available public records as described in this letter, as well as that information received by our office during the Open Records Period. There has been insufficient evidence that the duplex currently located on the site was constructed legally. As a result, the use of the structure for a duplex dwelling is **NOT APPROVED** and a single-family residence is the only dwelling allowable on the subject property, subject to Article VII of the City of Tampa code. The findings regarding the request are as follows:

1. The property was zoned R-1 from January 1956 until December 17, 1987.
2. The R-1 zoning district permitted one single-family dwelling per zoning lot.
3. The property was rezoned to RS-50 during the Zoning Conformance Process.
4. The future land use designation is R-10.
5. Per the Hillsborough County Property Appraiser's website, the property is described as: "CYPRESS ESTATES LOT 6 BLOCK 2".
6. Per the Hillsborough County Property Appraiser's website, shows the Building Characteristics of the property as "duplex/triplex/quadplex" built in 1962.
7. The City's old Situs database reflects the use as a duplex with the zoning as R-1 (Exhibit A).

Section 27-43 – Definitions, defines nonconformities as "[T]hose characteristics of the property, structure, or use, as determined through a formal decision, which are not permitted in the schedule of permitted uses or do not conform to the schedule of area, height, bulk, and placement regulations, or other provisions of this chapter, *but were legal at the time they were established (emphasis added)*".
27. Section 27-297. Nonconforming uses of major structures of structures and premises in combination reads as follows:
 

**"Sec. 27-297. Nonconforming uses of major structures or structures and premises in combination.**

Nonconforming use(s) of structure(s) with a value higher than the respective values set forth in section 27-296 shall be considered a major structure, and may be continued exactly as such use(s) existed at the time its nonconforming status was established, provided:

  - (1) A nonconforming use may not be enlarged, extended, intensified, or changed, except for a change to a use permitted in the district in which the property is located, except as provided below.
    - a. A nonconforming use may be extended through portions of a building manifestly arranged or intended for such use, and,
    - b. A nonconforming use shall not extend to occupy land outside such building, or any additional building not used for such nonconforming use at the time that nonconforming status was established.

(2) If there is an intentional and voluntary abandonment of a nonconforming use for a period of more than one hundred eighty (180) consecutive days, or if a nonconforming use is changed to a conforming use, said use shall lose its nonconforming status. Thereafter, subsequent occupancy and use of the land, building, and/or structure shall conform to the regulations of the districts in which the property is located and any structural alterations necessary to conform the structure or building to the regulations of the district in which the property is located shall be required. An intentional and voluntary abandonment of use includes, but is not limited to, vacancy of the building or structure in which the nonconforming use was conducted, or discontinuance of the activities consistent with or required for the operation of such nonconforming use.

(3) Upon the zoning administrator's own action or through the formal decision process set forth in section 27-54, the zoning administrator will evaluate the evidence of an intentional and voluntary abandonment of a nonconforming use and determine the status of the nonconforming use. The evidence, collectively, must at a minimum demonstrate the following:

1. Continual operation (or intent to operate) of the use;
2. Continual maintenance (or intent to maintain) of the structure and property;
3. Continual possession of any necessary and valid state and local permits, licenses, or active/pending application(s) for approval related to prolonging the existence of the use.

Evidence of an intentional and voluntary abandonment of a nonconforming use may include, but is not limited to, public records, utility records, property records, personal records, or other general research and documentation as follows:

1. Public records, including those available through applicable City of Tampa, Hillsborough County, and State of Florida agencies;
2. Utility records, including water/sewer accounts, solid waste accounts, and electricity accounts;
3. Property records, including executed lease or sales contracts and real estate listings for property sale/lease/rent;
4. Personal records, including photographs and notarized statements of direct personal observations;
5. Other general research and documentation, including listings from the Polk Directory, Burgert Brothers photographs, SanBorn Maps, aerials and other maps available through a geographic information system.

(4) When building(s) or structure(s) devoted to a nonconforming use are destroyed or damaged, by any cause, to the extent of sixty (60) percent or more of the current assessed taxable value of all the building(s) or structure(s) comprising the nonconforming use, such building(s) or structures, if restored, shall thereafter be devoted to conforming uses.

(5) No structural or non-structural alterations may be made to a nonconforming use, except where the following type alterations do not conflict with the provisions set forth above:

- a. Alterations made in the course of ordinary maintenance and repairs, or
- b. Alterations made to comply with the requirements of law, or

- c. Alterations made to accommodate a conforming use provided the alteration does not increase the degree on nonconformity, or
- d.
