A RESOLUTION APPROVING THE RENEWAL OF AWARDS BETWEEN THE CITY OF TAMPA AND THE FOLLOWING AWARDEES: ADVANCED ARBORIST, LLC, MID-FLORIDA TREE SERVICE, INC. AND PETE & RON'S TREE SERVICE, INC., WITHOUT A CONSUMER PRICE INDEX (CPI) PRICE ESCALATION, FOR THE FURNISHING OF CITYWIDE TREE SERVICES IN THE ESTIMATED AMOUNT OF \$1,500,000 FOR USE BY THE PARKS AND RECREATION DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Tampa, Florida, by authority contained in Resolution No. 2022-504, passed and adopted by City Council on June 16, 2022, entered into awards with Advanced Arborist, LLC, Mid-Florida Tree Service, Inc. and Pete & Ron's Tree Service, Inc. for the furnishing of Citywide Tree Services for use by the Parks and Recreation Department; and

WHEREAS, the City of Tampa, Florida, by authority contained in Resolution No. 2023-536, passed and adopted by City Council on June 1, 2023, renewed the awards with Advanced Arborist, LLC, Mid-Florida Tree Service, Inc. and Pete & Ron's Tree Service, Inc. for the furnishing of Citywide Tree Services for use by the Parks and Recreation Department; and

WHEREAS, the City of Tampa, Florida, by authority contained in Resolution No. 2024-24, passed and adopted by the City Council of the City of Tampa on January 11, 2024, approved additional expenditures within existing awards with Advanced Arborist, LLC, Mid-Florida Tree Service, Inc. and Pete & Ron's Tree Service, Inc. for the furnishing of Citywide Tree Services in the amount of \$1,230,000; and

WHEREAS, the City of Tampa, Florida, by authority contained in Resolution No. 2024-463, passed and adopted by City Council on June 6, 2024, renewed the awards with Advanced Arborist, LLC, Mid-Florida Tree Service, Inc. and Pete & Ron's Tree Service, Inc. for the furnishing of Citywide Tree Services for use by the Parks and Recreation Department; and

WHEREAS, the City of Tampa, Florida, by authority contained in Resolution No. 2025-383, passed and adopted by City Council on May 1, 2025, renewed the awards with Advanced Arborist, LLC, Mid-Florida Tree Service, Inc. and Pete & Ron's Tree Service, Inc. for the furnishing of Citywide Tree Services for use by the Parks and Recreation Department; and

WHEREAS, said awards provided for renewal under the same terms and conditions as contained therein when mutually agreeable to the parties, and the parties have mutually agreed to such extension without a Consumer Price Index (CPI) price escalation.

NOW, THEREFORE,

**BE IT RESOLVED BY THE CITY COUNCIL
OF THE CITY OF TAMPA, FLORIDA:**

Section 1. That, pursuant to Resolution No. 2022-504, passed and adopted by the City Council on June 16, 2022, the City of Tampa is renewing the awards with Advanced Arborist, LLC, Mid-Florida Tree Service, Inc. and Pete & Ron's Tree Service, Inc. for an additional one-year period commencing at 12:01 a.m., June 16, 2026 and expiring at 12:00 midnight, June 15, 2027 upon the same terms and conditions as contained in the original awards.

Section 2. This Resolution renews the awards between the City of Tampa and the following awardees: Advanced Arborist, LLC, Mid-Florida Tree Service, Inc. and Pete & Ron's Tree Service, Inc. for the furnishing of Citywide Tree Services in the estimated amount of \$1,500,000, without a Consumer Price Index (CPI) price escalation, over a 12-month term, subject to annual appropriation, for use by the Parks and Recreation Department within the General Fund.

Section 3. That the other proper officers of the City of Tampa are authorized to do all things necessary and proper in order to carry out and make effective the provisions of this Resolution, which shall take effect immediately upon its adoption.
