

**AMENDMENT TO EMERGENCY SOLUTIONS GRANT RAPID UNSHELTERED HOUSING AGREEMENT**

**THIS FIRST AMENDMENT** (“Amendment”) to Emergency Solutions Grant Agreement Rapid Unsheltered Housing (ESG-RUSH) is entered into by the City of Tampa, a municipal corporation organized and existing under the laws of the State of Florida (“City”) and Dawning Family Services, Inc. A Florida Nonprofit Corporation (“Subrecipient”) as of July 26, 2024 (“Amendment Date”).

**RECITALS**

A. City and Subrecipient entered in that certain Emergency Solutions Grant Agreement (ESG-RUSH) (“Original Agreement”), as approved by City Council Resolution No. 2023-929 on September 21, 2023, and signed by the Mayor on October 7, 2023, for the provision of services to individuals and families experiencing or at risk of homelessness in the City of Tampa (collectively, the “Agreement”); and

B. City and Subrecipient wish to amend the Agreement to provide for additional time. Specifically, to extend the contract end date from September 30, 2024, to December 31, 2024.

**FOR CONSIDERATION RECEIVED**, the parties agree as follows:

1. The foregoing recitals are true and correct and by this reference made a part hereof.
2. Article II to the Agreement, entitled “PERIOD OF THE AGREEMENT; EFFECTIVE DATE”, is deleted in its entirety and replaced with the following new Article II:

**Article II - PERIOD OF THE AGREEMENT; EFFECTIVE DATE**

This Agreement shall remain and shall continue in full force and effect through to December 31, 2024, unless terminated or earlier cancelled. Costs intended to be charged against Grant Funds allotted to Subrecipient hereunder may not be incurred after December 31, 2024, without a written amendment to this Agreement. Notwithstanding anything herein to the contrary, Subrecipient’s obligations to the City shall not end until all close-out requirements are completed, including, but not limited to, such things as making final payments, disposing of program assets, retention of records, and use and maintenance requirements; further, this Agreement and the provisions herein shall be deemed extended to cover any additional time period during which the Subrecipient remains in control of grant funds allocated hereunder, or other assets, including program income, or for any audits allowed hereunder.

3. Except as amended herein all provision of the Agreement remain in full force and effect. All capitalized terms used in this Amendment, unless otherwise defined or modified, shall have the same meaning as set forth in the Agreement. The Agreement remains unchanged except as modified by this Amendment. The terms and provisions of the Agreement, as modified by this Amendment, are ratified, and affirmed.

4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, but all shall constitute one and the same amendment; provided, however, this Amendment shall not be effective until fully executed by both parties and subject to the formalities required by the City of Tampa Code.


