**Subject:** Fifth Amendment to ESG Rapid Unsheltered Housing Agreement with Dawning Family Services, Inc., extending term to September 30, 2026.

**Resolution / Ordinance Title:** A resolution approving a fifth amendment to emergency solutions grant rapid unsheltered housing agreement between the city of Tampa and Dawning Family Services, Inc., a Florida nonprofit corporation, in an amount not to exceed \$1,300,000.00, for the provision of services in support of individuals and their families experiencing homelessness within the city of Tampa; extending the term of the agreement to September 30, 2026; approving and authorizing execution by the mayor and attestation by the city clerk; providing an effective date.

**BACKGROUND:**

Dawning Family Services, Inc., has partnered with the City of Tampa to provide services in support of homeless persons and families within the City of Tampa. Non-Grant Program funds will provide emergency shelter and rapid rehousing services, and support both staff and program operations.

This amendment provides an extension of time. The additional time will allow Dawning Family Services to continue to provide their shelter services, rapid rehousing programs, and to continue the work to develop their family solutions center and improve their family welcome center.

Staff is requesting City Council's consideration and approval of the attached agreement and resolution to allow for the execution of the Amendment that will allow for the extension of time.
