Good Afternoon Chairman Clendenin,


On behalf of the applicant, we are requesting this first continuance of REZ 25-48 and VAC 25-08, which are currently scheduled for the November 13, 2025 City Council evening agenda. In order to address a few remaining solid waste comments and to resubmit a revised site plan with these solid waste updates, we are requesting a continuance to **January 15, 2026**.

These two cases are also associated with CPA 24-11. Since the project's inception, we have communicated with the various neighborhood groups and neighbors that we intend for all three (3) applications to be heard on the same night. Therefore, I will be following up with a request to continue CPA 24-11 to January 15, 2026 as well.

We kindly request that these items be rescheduled to the **January 15, 2026** hearing date in order to address a few remaining solid waste comments and to submit a revised site plan by the November 20, 2025 site plan deadline.
