Resolution / Ordinance Title: A Resolution approving a SkillUp Coalition Localization Partner Agreement between the City of Tampa and SkillUp Coalition, a California 501(c) 3 nonprofit public benefit corporation for use by the Neighborhood & Community Affairs Department, at no cost to the City; authorizing the Mayor to execute said Agreement, providing an effective date.

BACKGROUND:

SkillUp Coalition, Inc (SkillUp) is a nonprofit that enables job seekers to embark on new careers regardless of their degree-holding status by featuring high-quality training with low risk and high returns and are dedicated to educating participants on how to achieve promising career paths; and SkillUp retains a Central Florida platform featuring career navigation resources, curated training programs and employer partnerships; and the City of Tampa through its Neighborhood and Community Affairs Department desires to partner with SkillUp to provide employment navigation services to Licensor at no cost to the city; and City Council does hereby affirm that it would be beneficial to the residents of the City to enter into this Copyright License and Indemnity Agreement between the City of Tampa and University of South Florida Board of Trustees.
