

**RESOLUTION NO. 2026-**

A RESOLUTION MAKING CERTAIN CHANGES IN THE BUDGET OF THE CITY OF TAMPA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2026; APPROVING THE TRANSFER, REALLOCATION, AND/OR APPROPRIATION OF \$5,000.00 WITHIN THE PUBLIC SAFETY CONTRIBUTIONS & DONATIONS FUND FROM THE FRANK MANGANO FOUNDATION FOR USE BY TAMPA FIRE RESCUE; PROVIDING AN EFFECTIVE DATE.
