

RESOLUTION NO. 2025- 704

A RESOLUTION MAKING CERTAIN CHANGES IN THE BUDGET OF THE CITY OF TAMPA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2025; APPROVING THE TRANSFER, REALLOCATION, AND/OR APPROPRIATION OF \$1,000,000 WITHIN THE PARKS AND RECREATION GRANTS CAPITAL PROJECTS FUND FOR USE BY THE EAST TAMPA RECREATIONAL COMPLEX PROJECT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, additional revenue or unappropriated surplus, or funds previously appropriated which are no longer needed for their original purpose, are available for transfer, reallocation and/or appropriation to accounts within the Parks and Recreation Capital Projects Fund, and such transfer, reallocation and/or appropriation is for a necessary municipal purpose.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TAMPA, FLORIDA, THAT:

Section 1. The transfer, reallocation, and/or appropriation of the sum of \$1,000,000 within the Parks and Recreation Capital Projects Fund, as set forth below, is hereby approved.
