Subject: A resolution approving FY2022 Community Project Funding Grant Agreement No. B-22-CP-FL-0248 between the City of Tampa and the Department of Housing and Urban Development.

Resolution / Ordinance Title: A resolution approving FY2022 Community Project Funding Grant Agreement No. B-22-CP-FL-0248 between the City of Tampa and the Department of Housing and Urban Development; Authorizing execution thereof by the Mayor of the City of Tampa and attestation by the City Clerk; Providing an effective date; Rescinding resolution No. 2025-699, which approved the original Grant Agreement on August 7, 2025.

BACKGROUND:

The City of Tampa was awarded Community Project Funding for the East Tampa Recreation Center at Fair Oaks project in the amount of \$1,000,000. Through resolution 2025-699, the City Council of the City of Tampa approved a Grant Agreement between the City of Tampa and the Department of Housing and Urban Development, which awarded grant funding in the amount of \$1,00,000 for the East Tampa Recreation Center at Fair Oaks project. It is necessary to rescind Resolution No. 2025-699 as the Department of Housing and Urban Development provided an updated Grant Agreement prior to fully executing the agreement previously approved. This resolution also proposes to approve the revised FY2022 Community Project Funding Grant Agreement NO. B-22-CP-FL-0248 which was updated by the Department of Housing and Urban Development prior to fully executing the previously approved agreement. There is no financial impact resulting from this revised grant agreement as the funding associated (\$1,000,000) was appropriated by resolution 2025-704.
