

**RESOLUTION NO. 2026 - \_\_\_\_\_**

**A RESOLUTION APPROVING, RATIFYING AND CONFIRMING THE APPOINTMENT OF MICHAEL WOMACK AS A MEMBER OF THE CITY OF TAMPA CODE ENFORCEMENT AND PUBLIC NUISANCE ABATEMENT BOARD, AND FRAN TATE AS AN ALTERNATE MEMBER OF THE CITY OF TAMPA CODE ENFORCEMENT AND PUBLIC NUISANCE ABATEMENT BOARD, EACH FOR A THREE-YEAR TERM COMMENCING FEBRUARY 19, 2026, AND ENDING FEBRUARY 19, 2029; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to the authority contained in Ordinance 2015-50, passed and ordained by the City Council of the City of Tampa on April 16, 2015, City Council is authorized to appoint certain members to the Code Enforcement Board; and,

**WHEREAS**, pursuant to the authority contained in Ordinance 2017-105, passed and ordained by the City Council of the City of Tampa on July 13, 2017, the City of Tampa Code Enforcement Board is designated to act as the Public Nuisance Abatement Board; and,

**WHEREAS**, the City Council of the City of Tampa, by motion and vote on February 19, 2026, has appointed Michael Womack as a member of the Code Enforcement and Public Nuisance Abatement Board; and,

**WHEREAS**, the City Council of the City of Tampa, by motion and vote on February 19, 2026, has appointed Fran Tate as an alternate member of the Code Enforcement and Public Nuisance Abatement Board.

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL  
OF THE CITY OF TAMPA, FLORIDA:**

**Section 1.** That the City Council of the City of Tampa approves, ratifies and confirms the appointment of Michael Womack as a member of the City of Tampa Code Enforcement and Public Nuisance Abatement Board, for a three-year term commencing February 19, 2026, and ending February 19, 2029.

**Section 2.** That the City Council of the City of Tampa approves, ratifies and confirms the appointment of Fran Tate as an alternate member of the City of Tampa Code Enforcement and Public Nuisance Abatement Board, for a three-year term commencing February 19, 2026, and ending February 19, 2029.

**Section 3.** That the proper officers of the City of Tampa are hereby authorized to do all things necessary and proper in order to carry out and make effective the provisions of this Resolution.

**Section 4.** This Resolution shall take effect nunc pro tunc to February 19, 2026.
